THE APPLICATION of the PricewaterhouseCoopers Inc. (“PWC”), Trustee in Bankruptcy of Holiday Travel Consultants Ltd., coming on for hearing before me this day at Vancouver, British Columbia; AND UPON HEARING John I. McLean, Shelley C. Fitzpatrick, and Colin D. Brousson, Counsel for the Trustee, Robert D. Standerwick, Counsel for the Royal Bank of Canada, and no one else appearing although duly served; AND UPON READING the Affidavit of Gord McMorran #1, sworn November 20, 2001 and filed herein,

THIS COURT ORDERS that

1. the obligation of the Trustee to call a first meeting of creditors of Holiday Travel Consultants Ltd. be and is hereby extended to a date to be fixed by the Court on further application, such application to be made on or before January 30, 2002;

2. the obligation of the Trustee to forward certain mailings to the creditors, including without limitation, the Notice to Bankrupt of Meeting of Creditors and the Notice of Bankruptcy and First Meeting of Creditors, pursuant to the *Bankruptcy and Insolvency Act*, be and is hereby dispensed with pending an Order of the Court to be obtained on further application, such application to be made on or before January 30, 2002;
3. the Trustee forthwith publish notice of the bankruptcy and the terms of this Order in one Saturday edition of the National Post newspaper and by posting on the website maintained by PricewaterhouseCoopers Inc. at www.pwcglobal.com/bris-canada3000
4. this Order and any other Orders in these proceedings shall have full force and effect in all provinces and territories of Canada. This Court seeks and requests the aid and recognition of other Canadian and foreign courts and administrative bodies, to act in aid of and to be complementary to this Court in carrying out the terms of this Order where required.
