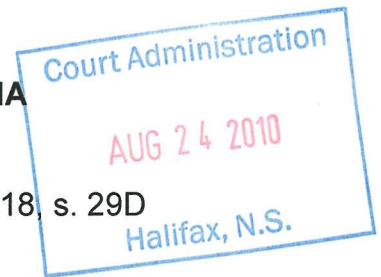

**ORDER**

**BEFORE THE HONOURABLE JUSTICE** Justice Patrick J. Duncan **IN CHAMBERS**

**PJD, J.** **UPON READING** the Affidavit of James A. Pomeroy on behalf of PricewaterhouseCoopers Inc., Receiver of the assets and property of Jabez Financial Services, Inc., sworn on July 19, 2010;

**AND UPON HEARING** Stephen Kingston and Justin Kimball, counsel for the Receiver;

**AND UPON IT APPEARING** Jabez Financial Services, Inc. was duly served with the Notice of Motion, associated pleadings and submissions filed by the Receiver herein in accordance with the Order of this Honourable Court in this proceeding issued on November 18, 2009;

**AND UPON IT APPEARING** the Receiver has collected property and assets of Jabez Financial Services, Inc. pursuant to its mandate and powers as set forth in the Order of March 2, 2007 in this proceeding ("Receivership Order") and has administered a claims process pursuant to the Claims Procedure Order issued on March 8, 2010 in this proceeding;

**AND UPON IT APPEARING** the Receiver seeks the directions and approval of this Honourable Court with respect to an initial distribution to proven creditors from amounts the Receiver holds under its mandate;

**NOW UPON MOTION:**

**IT IS HEREBY ORDERED THAT:**

**Service of materials**

1. PricewaterhouseCoopers Inc., Receiver of the assets and property of Jabez Financial Services, Inc. ("Jabez"), is not required to serve notice of this motion on any person save and except for Jabez in accordance with the Order herein dated November 18, 2009.

**Distribution of Funds**

2. The Receiver be and is hereby authorized to distribute US\$500,000 from the property and assets the Receiver has collected under its mandate in this proceeding, which distribution shall be made in payments to the proven creditors in the Jabez receivership estate on a *pro rata* basis in accordance with their respective proven claims as admitted by the Receiver.

**AND IT IS HEREBY ORDERED THAT:**

3. All costs of the Receiver and its counsel relating to the distribution of funds including costs of this motion shall be paid by the Receiver out of the amounts collected under its mandate and may be included in the accounts of the Receiver, subject to any assessment as may be required pursuant to the Receivership Order.


