

This memorandum summarizes the results of the Personal Property Registry we have caused to be conducted in British Columbia (and in some cases, Alberta and Ontario) against Catalyst and the Guarantors in order to determine whether any security interests have been registered against the personal property of Catalyst or any of the Guarantors.
