**Part 4: FACTUAL BASIS**

1. In early 2001, Powell River Energy Trust (“**PRET**”) and Pacifica Papers Inc. (“**Pacifica**”, and each a “**Limited Partner**”) formed the Powell River Limited Partnership (the “**Limited Partnership**”) pursuant to a limited partnership agreement dated January 31, 2001 (the “**Limited Partnership Agreement**”).
2. The General Partner of the Limited Partnership is 3795659 Canada Limited, which is owned by Powell River Energy Inc. (“**PREI**”). PREI was originally owned by PRET and Pacifica.
3. PREI is subject to a unanimous shareholders agreement dated January 31, 2001 (the “**USA**”).
4. On or about March 5, 2010, Catalyst Paper Corporation (the successor name of Pacifica), transferred its interest in the Limited Partnership and PREI to its wholly owned subsidiary Catalyst Paper Energy Holdings Inc. (“**CPEH**”) pursuant to the terms of the Limited Partnership Agreement and the USA.
5. Both the Limited Partnership Agreement and the USA provide a right of first refusal (“**ROFR**”) to the remaining Limited Partner if a Limited Partner wishes to sell its interest in the Limited Partnership or PREI.
6. CPEH is included as a Seller in the Stalking Horse Purchase Agreement. However, it is unclear whether the assets being sold include the interest of CPEH in the Limited Partnership or PREI. To the extent they do, this would be subject to the ROFR, and the Stalking Horse Purchase Agreement and any other agreement purporting to sell the interest of CPEH in the Limited Partnership or PREI must be subject to the ROFR.
