In keeping with the previous reporting timelines, the Monitor will issue its report on the fairness and reasonableness of the Plan on or before April 25, 2012, being 7 days prior to the Creditors' Meetings. The Monitor will file its report with the Court and post a copy of that report on its website (www.pwc.com/car-catalystpaper).

The Monitor notes that **the claims bar date for all creditor claims is April 18, 2012 at 5:00 pm (Pacific Time). This date is unaffected by the rescheduling of the Creditors' Meetings** and all claims are required to be submitted by this date.
