THIS COURT ORDERS THAT:



2. Notwithstanding the foregoing:
 - (a) the Ninth Report, other than the schedules attached to Appendix B thereto (collectively, the "**Confidential Schedules**"), be made available to all stakeholders, and the Monitor be authorized and directed to post the Ninth Report

without the Confidential Schedules on the Monitor's Website (as defined in the Amended and Restated Initial Order of this Court dated February 3, 2012 (the "Amended Initial Order")); and

(b) the Monitor, with the consent of the Petitioners, is hereby permitted to disclose any of the Confidential Schedules to any party requesting such disclosure, provided (i) the requesting party first signs a confidentiality agreement in favour of the Petitioners and the Monitor, and (ii) the disclosure of the Confidential Schedules requested would not result in the disclosure of competitive information to a competitor or supplier of the Petitioners and would not be prejudicial to any process for the sale of any of the Petitioners' assets.


3. The approval of counsel set out in Schedule "B" of this Order is hereby dispensed with.
