TAKE NOTICE that an application will be made by the Petitioners to Mr. Justice Sewell at the  
courthouse at 800 Smithe Street, Vancouver, British Columbia on June 25, 2012 at ~~2:00 p.m.~~ <sup>10:00 a.m.</sup> for  
the orders set out in Part 1 below.

## **Part 1: ORDERS AND DECLARATIONS SOUGHT**

1. An Order, substantially in the draft form attached as **Schedule “B”** hereto, extending the stay of proceedings.

## **Part 2: FACTUAL BASIS**

1. On January 31, 2012, the Court granted an Initial Order (the “**Initial Order**”) in respect of the Petitioners and Catalyst Paper General Partnership (collectively the “**Company**”) providing for a comeback hearing on February 14, 2012 and a stay of proceedings until that same date (the “**Stay**”). The Initial Order appointed PricewaterhouseCoopers Inc. as the monitor of the Company (the “**Monitor**”) in the CCAA proceedings.

2. On February 3, 2012, the Court granted an Order amending and restating the Initial Order. Since that date, various other Orders have been granted by the Court.

3. On February 14, 2012, the Court granted an order extending the Stay to April 30, 2012.

4. On April 19, 2012, the Court granted an order further extending the Stay to June 30, 2012.

5. Pursuant to various orders of this Court: (a) certain creditors of the Company are scheduled to vote on a Second Amended and Restated Plan of Compromise and Arrangement (the “**Second Amended Plan**”) on June 25, 2012; (b) a Sanction Hearing is scheduled for June 28, 2012; and (c) a sales and investor solicitation process is ongoing.

6. As a result of the above, the Stay is required to be extended.

7. The Petitioner Parties have continued to take steps to stabilize the business and have and are acting in good faith and with due diligence. Circumstances exist that make the Orders sought appropriate.

**Part 3: LEGAL BASIS**

1. *Supreme Court Civil Rules*, Rule 8-1, 13-1;
2. *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended;
3. The inherent and equitable jurisdiction of the Court; and
4. Orders previously pronounced by the Court in this proceeding.
