1. On March 22, 2013, pursuant to an order (the "**Receivership Order**") of the Ontario Superior Court of Justice (Commercial List) (the "**Court**"), PricewaterhouseCoopers Inc. ("**PwC**") was appointed receiver (the "**Receiver**"), without security, of all of the assets, undertakings and property (the "**Property**") of PRACS Institute Canada B.C. Ltd. ("**PRACS**" or the "**Company**") acquired for, or used in relation to a business carried on by the Company, pursuant to section 243 (1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the "**BIA**") and section 101 of the *Courts of Justice Act*, R.S.O. 1990, c. C.43, as amended.
2. The Receivership Order was granted pursuant to an application made by Freeport Financial LLC ("**Freeport**"), pursuant to its security agreements with the Company, including a General Security Agreement dated June 20, 2012, as amended, restated, modified, or supplemented from time to time.
3. On March 22, 2013, the Receiver took possession of the Company's Property, which primarily consisted of:
