**ORDER**

**UPON THE APPLICATION OF** PricewaterhouseCoopers Inc., court-appointed Interim Receiver (the “Receiver”) of all of the properties, assets and undertakings of Shane Scott and Michelle Scott (collectively, the “Debtors”), **AND UPON HEARING** Mike Russell, counsel for the Receiver, David Gerecke, counsel for Bank of Montreal, and counsel for other interested parties; **AND UPON HAVING READ** the Interim Receivership Order of the Honourable Madam Justice A.R. Rothery issued in these proceedings and dated October 9, 2012 (the “Interim Receivership Order”), the Orders of the Honourable Madam Justice A.R. Rothery dated November 8, 2012, November 22, 2012, and December 6, 2012, each extending the Interim Receivership Order, the Notice of Motion of the Receiver dated January 15, 2013 (the “Receiver’s Notice of Motion”), the Fifth Report of the Interim Receiver dated January 15, 2013, and a proposed form of draft Order, all filed;

**IT IS HEREBY ORDERED, ADJUDGED AND DECLARED THAT:**

1. The time for service of the Receiver's Notice of Motion and the other materials filed in support of this application (collectively, the "Application Materials") shall be and is hereby abridged, such that service of the Application Materials on Tuesday, January 15, 2013, shall be deemed to constitute good, valid and timely service thereof in regard to the application scheduled for hearing at 9:00 a.m. on Friday, January 18, 2013.
2. Paragraph 18 of the Interim Receivership Order shall be and is hereby amended to increase the Receiver's borrowing empowerment, as secured by the Interim Receiver's Borrowings Charge, from the principal amount of \$100,000.00 to the principal amount of \$250,000.00.
