**ORDER**

**UPON THE APPLICATION OF** PricewaterhouseCoopers Inc., court-appointed Receiver (the “**Receiver**”) of all of the properties, assets and undertakings of Shane Scott and Michelle Scott (collectively, the “**Debtors**”), **AND UPON HEARING** Mike Russell, counsel for the Receiver, David Gerecke, counsel for Bank of Montreal, Stuart Busse, counsel for the Debtors and other interested parties; **AND UPON HAVING READ** the Amended and Restated Receivership Order of the Honourable Madam Justice A.R. Rothery issued in these proceedings and dated February 15, 2013 (the “**Receivership Order**”), the Notice of Motion of the Receiver dated April 17, 2013 (the “**Receiver’s Notice of Motion**”), the Eighth Report of the Receiver and a proposed form of draft Order, all filed;

**IT IS HEREBY ORDERED, ADJUDGED AND DECLARED THAT:**


1. The time for service of the Receiver’s Notice of Motion and the other materials filed in support of this application (collectively, the “**Application Materials**”) shall be and is

hereby abridged, such that service of the Application Materials shall be deemed to constitute good, valid and timely service thereof.

2. The Application for Hearing on behalf of Shane Scott and Michelle Scott pursuant to Part IV of *The Saskatchewan Farm Security Act* dated March 18, 2013 (the "**Application for Hearing**") shall be and is hereby deemed to have been filed with the Court in the Judicial Centre of Saskatoon on April 5, 2013.
3. The Application for Hearing is set for Thursday, May 9, 2013, at 1:30 p.m. at the Judicial Centre of Saskatoon.
4. Counsel for Shane Scott and Michelle Scott consents to the date upon which the Application for Hearing is deemed to have been filed and the date and location of the hearing set.
5. The issue as to whether certain cattle on the Debtors' property are owned by Samuel Brady Scott or his siblings is to be brought by Motion on Thursday, May 9, 2013, at 1:30 p.m. by his legal guardians, failing which, the Receiver is entitled to deal with the cattle presently on the Debtors' property in accordance with the Receivership Order.
