THE WITHOUT NOTICE APPLICATION of PricewaterhouseCoopers Inc.,  
Receiver and Manager of The Symphony Development Corporation (the "Receiver"), coming on  
for hearing before me this 30<sup>th</sup> day of June, 2010, at Vancouver, British Columbia; AND UPON  
HEARING Meagan Lang, counsel for the Applicant:

THIS COURT ORDERS THAT:

1. the Order of the Honourable Mr. Justice Walker pronounced June 22, 2010 and entered June 23, 2010 be amended as follows:

- (a) paragraph 2.(d) of the Order be deleted in its entirety and replaced with the following:

2. (d) fourthly, the balance, if any, shall be paid to the Receiver to the credit of this proceeding, which proceeds shall stand in place and stead of the rights of the parties hereto who have registered charges in accordance with the priorities affecting the Lands, such that the charges and the priorities of the parties with the charges shall affect the proceeds in the same manner as if the proceeds were the Lands and no person shall gain any priority or right to rank equally in priority with a prior ranking charge as against such proceeds.

- (b) paragraph 3. of the Order be deleted in its entirety and replaced with the following


3. for the purpose of issuing title in respect of the Lands, the charges, liens, encumbrances, caveats, mortgages and certificates of pending litigation set out in Schedule "B" hereto, and any other charges, liens, encumbrances, caveats, mortgages and certificates of pending litigation that are registered to Lands by any of the parties to this Order of the Court, together with all charges, liens, encumbrances, caveats, mortgages and certificates of pending litigation registered subsequent to Certificate of Pending Litigation BB40816 (as it charges Lots 1 to 45, inclusive, all of Section 10 Township 12 New Westminster District Plan BCP36341) and Certificate of Pending Litigation BB340600 (as it charges Lot 1 Section 10 and 11 Township 12 New Westminster District Plan BCP35626), be cancelled insofar as they apply to the Lands.


- (c) Schedule "B" of the Order be deleted in its entirety and replaced with Schedule "B" attached hereto;
- (d) Schedule "D" of the Order be deleted in its entirety and replaced with Schedule "D" attached hereto.

2. this Order shall be entered on an expedited basis.
