1. The time for service of the Notice of Application and affidavit in support be and is hereby abridged and the application is properly returnable this day;
2. The Order granted in this proceeding on January 12, 2010 (the January 12, 2010 Order"), shall be amended *nunc pro tunc* by deleting paragraph 1 thereof in its entirety and inserting in its place the following:
 - "1. THIS COURT ORDERS that, pursuant to Section 39 of the LEA, PricewaterhouseCoopers Inc. is hereby appointed Receiver and Manager, without security, of all of the Debtor's current and future assets, undertaking and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof (the "Property")."
3. For greater certainty:
 - (a) the appointment of PricewaterhouseCoopers Inc. as Receiver and Manager of The Symphony Development Corporation shall be deemed to have been continuous from and after January 12, 2010, and all actions and activities undertaken by PricewaterhouseCoopers Inc. in its capacity as Receiver and Manager of The Symphony Development Corporation shall be deemed to have been within the authority of the Receiver and Manager and validly undertaken pursuant to its appointment as Receiver and Manager pursuant to the January 12, 2010 Order; and
 - (b) the stay of proceedings and all other terms and conditions contained in the January 12, 2010 Order shall be deemed to have been in continuous effect from and after January 12, 2010.
