



NOTICE AND STATEMENT OF THE RECEIVER

(Pursuant to subsection 245(1) and 246(1)
of the *Bankruptcy and Insolvency Act*)

IN THE MATTER OF THE RECEIVERSHIP OF THE PROPERTY OF

XS CARGO LIMITED PARTNERSHIP and XS CARGO GP INC.

of the City of Mississauga, in the Province of Ontario

The Receiver gives notice and declares that:

1. On November 13, 2014, pursuant to an order (the “**Receivership Order**”) of the Ontario Superior Court of Justice (Commercial List) (the “**Court**”), PricewaterhouseCoopers Inc. (“**PwC**”) was appointed receiver (the “**Receiver**”), without security, of all of the assets, undertakings and properties (the “**Property**”) of XS Cargo Limited Partnership (“**XS LP**”) and XS Cargo GP Inc. (“**XS GP**”, and together with XS LP, “**XS Cargo**” or the “**Companies**”) acquired for, or used in relation to a business carried on by the Companies, pursuant to section 243 (1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended (the “**BIA**”) and section 101 of the *Courts of Justice Act*, R.S.O. 1990, c. C.43 as amended.
2. The Receivership Order was granted pursuant to an application made by KarpReilly Capital Partners L.P. (“**KarpReilly**”), a secured creditor of the Companies, pursuant to its security agreements with the Companies, with respect to a mezzanine loan provided to the Companies by KarpReilly, KarpReilly Direct, LLC, Famous Brands Inc., Mark L. Butler, Gerry Bachynski and Sean Britain (collectively the “**Mezzanine Loan Lenders**”).
3. Prior to the commencement of the receivership proceedings on July 30, 2014, XS Cargo filed Notices of Intention to Make a Proposal (the “**NOI**”) pursuant to subsection 50.4 (1) of the BIA and PwC was named as trustee under the NOI (the “**Proposal Trustee**”).
4. On October 30, 2014, XS Cargo filed its proposal dated October 29, 2014 (the “**Proposal**”) with the Proposal Trustee on the evening of October 30, 2014 pursuant to the provisions of the BIA, which was filed with the Office of the Superintendent of Bankruptcy (the “**OSB**”) on the same day. On October 31, 2014, a Certificate of Filing of a Proposal was issued by the OSB.

5. A meeting of XS Cargo’s creditors was held on November 20, 2014 to consider and vote on the Proposal (the “**Meeting of Creditors**”). At the Meeting of Creditors, XS Cargo’s creditors accepted the Companies’ Proposal. As a result, the Proposal Trustee will apply to the Court for a hearing of the application for approval of the Proposal by the Court.
6. During the NOI proceedings, the Proposal Trustee filed four reports with the Court (the “**Proposal Trustee’s Reports**”), which among other things provided the Court with information relating to the NOI proceedings, the Companies’ cash-flow, described the Proposal Trustee’s activities and conduct, particularly relating to a sale and investment solicitation process (the “**SISP**”) and the transaction for the sale of the Companies’ assets (the “**Sale Transaction**”). Copies of these reports and orders granted by the Court during the NOI proceedings can be obtained from the Trustee’s website at www.pwc.com/car-xscargo.
7. The SISP, which provided a means for testing the market and gauging interest in the Companies and/or their assets, was approved by order of the Court dated August 6, 2014 and resulted in an agency agreement and a purchase and sale agreement being entered into by the Companies and Tiger Group LLP (“**Tiger**”) for the liquidation of the Companies’ assets (the “**Transaction**”). The Transaction was approved by the Court on September 19, 2014. As at the date of this report, Tiger has completed the liquidation of all 50 stores of XS Cargo. The gross proceeds from the Transaction are anticipated to be approximately \$10 million, of which \$6.7 million has already been paid to XS Cargo by Tiger.
8. On November 13, 2014, the Receiver took possession of the Companies’ Property, which primarily consisted of:
