NOTICE OF LAST DAY (CLAIMS BAR DATE) FOR THE FILING OF PROOFS OF CLAIM

On November 14, 2007, Cygnal Technologies Corporation, Cygnal Technologies Ltd. and Accord Communications Ltd. (collectively, the "Applicants") filed for and obtained protection from their creditors under the *Companies' Creditors Arrangement Act* (the "CCAA") pursuant to an order of the Ontario Superior Court of Justice (the "Initial Order"). Pursuant to the Initial Order, PricewaterhouseCoopers Inc. was appointed by the court as Monitor in the CCAA proceedings (the "Monitor").

On November 23, 2007, the Applicants were granted an Order (the "Claims Procedure Order") that establishes a process for Creditors to prove Claims against the Applicants outstanding as of November 14, 2007 and Restructuring Claims arising after this date.

CLAIMS PROCEDURE

NOTICE IS HEREBY GIVEN that a procedure to determine the amount of Claims against the Applicants (the "Claims Procedure") was established by the Claims Procedure Order. Please take notice that Excluded Claims are not subject to this Claims Procedure.

THE CLAIMS BAR DATE for proving Claims is 5:00 p.m. (Toronto time) on December 31, 2007.

Any Creditor (other than Creditors with Excluded Claims, with respect to and to the extent of such Excluded Claims), must file a properly completed Proof of Claim with the Monitor on or before 5:00 p.m. Toronto time on the Claims Bar Date.

CREDITORS who do not file a Proof of Claim with the Monitor on or before 5:00 pm (Toronto time) on the Claims Bar Date will not be entitled to vote at the Creditors Meeting or obtain any distribution under a Plan, and their Claims (other than Excluded Claims), if any, will be forever extinguished and barred.
