- 3. Inadvertently, reference was omitted to John Deere Limited, which has asserted it has a security interest in the units which are the subject of this application pursuant, *inter alia*, to the terms of the following Security Agreements made between Hickman and John Deere Limited; a John Deere Industrial Dealer Agreement dated March 8, 1995, a John Deere Security Agreement Inventory dated January 26, 1993, and a fixed and floating charge Debenture dated March 11, 1985, and by reason of its two registrations, one dated December 14, 1999 as number 5595 and the other dated June 6, 2000 as number 328815, the latter in respect of the Debenture which was registered under the *Registration of Deeds Act*, on March 11, 1985.
- 4. PricewaterhouseCoopers Inc. has not issued a Final Determination in respect of John Deere Limited's claim to a security interest in the units which are the subject of this application. I am, however, advised by Carl Holm, Q.C., and verily believe, that he expects to recommend that the Trustee allow John Deere Limited's claim to a security interest in the units, with the priority of that interest to be determined.
