**WHEREAS** this matter has come for hearing on the 3<sup>rd</sup> day of February 2003;

**AND WHEREAS** the parties listed in Schedule "A" to this Order have been served with notice of this application in the manner ordered by this Court on March 28, 2002;

**AND WHEREAS** the parties listed in Schedule "B" to this Order have appeared and have been heard;

**AND UPON** reading the Affidavit of James Kirby, C.A., CIRP, Senior Vice President of PricewaterhouseCoopers Inc., St. John's, Newfoundland and Labrador, dated 24<sup>th</sup> January 2003 (the "Kirby Affidavit");

**IT IS THIS DAY ORDERED AS FOLLOWS:**

1. The time for service of the Application herein be and it is hereby abridged and validated such that 5 clear days notice of this Application upon the various Interested Parties be deemed adequate notice of the Application for the purposes of hearing this matter by this Honourable Court.
2. The Applicant is authorized to proceed with the sale to John Deere Limited ("JDL") of the Parts Inventory other than the Used Parts, all as described in a Consent and Priority Agreement (the "Agreement") between John Deere Limited ("JDL") and Canadian Imperial Bank of Commerce ("CIBC"), dated January 16, 2003, on the terms set out in an Offer made on behalf of JDL dated January 17, 2003 and in the Applicant's acceptance letter dated January 24, 2003 (the "Acceptance") attached hereto with the following modifications:
  - a. Paragraph (e) of the Acceptance is changed to provide as follows:
    - (e) the Purchase Price for the Purchased Parts, other than the 3T Parts and 1T Parts, shall be paid at closing, which shall occur at the offices of PricewaterhouseCoopers Inc. ("PWC"), St. John's, NL, within five (5) days of PWC obtaining Court Approval for the sale, provided that if Court Approval has not been obtained for immediate redistribution of the proceeds of sale so as to make JDL's offer unconditional, the offer shall remain conditional and the parties may at their mutual option extend the time for closing to provide a reasonable time for JDL and CIBC to obtain such an order or the offer may be withdrawn;
  - b. Paragraph (f) of the Acceptance is changed to provide as follows:

(f) the Purchase Price for the 3T Parts and 1T Parts shall be paid within five (5) days of JDL verifying the existence and condition and taking possession of those parts at the location where the trailers in which these parts are contained are located, provided that if JDL has not taken possession of such parts and paid for same by June 15, 2003, JDL shall pay to the Receiver an amount calculated by the Receiver in accordance with the provisions of paragraph 2(d) of the Agreement. The purchase price calculated by the Receiver acting reasonably will be binding on and immediately payable by JDL.

3. The Applicant is authorized without further Order of this Court to sell the Used Parts as defined in the Agreement, in whole or in part, by auction, private sale or such other method as the Applicant may deem appropriate;

4. Funds arising from the sale of Parts Inventory shall be held by the Applicant, pending further Order from this Honourable Court; and

5. All capitalized items in this Order, the Offer and the Acceptance shall have the meaning ascribed to them in the Agreement, except to the extent they are otherwise defined herein.


