1. The Receiver is granted leave to file its Interlocutory Application (Inter Partes) and draft Order with respect to the sale of an inventory of parts held by it as the Receiver of Hickman Equipment. This Application shall be heard on Thursday, December 30, 2002 at 10:00 a.m. with service to be effected in accordance with the terms of this order, at least 2 clear days prior to the hearing.
2. Service of any Applications and related documentation with respect to the matter of the Court Ordered Receivership and/ or bankruptcy of Hickman Equipment may be henceforth effected by forwarding such documents to the Receiver with a request for posting on the PricewaterhouseCoopers website, located on the world wide web at [www.pwcglobal.com/brs-hel](http://www.pwcglobal.com/brs-hel). The Receiver shall advise any Interested Party exercising this option if it is unable to meet the request. The Interested Party exercising this option for service shall:
  - (a) serve notice of the posting on all other secured creditors via fax and electronic correspondence; and
  - (b) allow the Receiver a minimum of 1 business day for posting.
