
ORDER ON INTERLOCUTORY APPLICATION (INTER PARTES)

Notwithstanding the time deadlines established by paragraphs 27 and 32 of the Receivership Order, the Receiver is hereby authorized to report to this Honourable Court regarding the status and affairs relating the performance of its duties and to provide a detailed accounting of its accrued fees and disbursements with each such report, as is more particularly described in paragraphs 27 and 32 of the Receivership Order, on a quarterly rather than monthly basis; the first of such quarters being from May - July 2003.
