Anders Laukvik, Member of the International Humanitarian Partnerships (IHP) Operations Support Unit which supports UNDAC

Anders has since 1996 worked with emergency response, both in his native country of Norway and with the International Humanitarian Partnerships (IHP) Operations Support Unit which supports the United Nations Disaster Assessment and Coordination (UNDAC) Team. In his daily life Anders works as Watch Commander for the Fire Departments Command Post in the State of Telemark. His work experience also includes Military, Civil Defense and international humanitarian relief. Anders is regularly used by the United Nations and MERCY Malaysia as a trainer and exercise coordinator.

Azeem Patterson, MERCY Malaysia

Azeem is a Programme Officer in MERCY Malaysia's Disaster Risk Reduction Department. Azeem is responsible for managing Community-based DRR projects in Malaysia, Maldives and China. He played a lead-role in development of MERCY Malaysia's School Preparedness Programme. Azeem has a Masters of International Social Development.

Datuk Peter Wentworth OBE, CEO Solutions

Peter has spent over 40 years in the Oil & Gas industry until retiring from BP in June this year to join the CEO Solutions Partnership. Prior to retirement he was CEO of BP Malaysia, Philippines & Thailand and for 5 years and was responsible for BP's Asia Regional Crisis Management Team which operated from KL.
