Government Decision no. 776/2009 was published in the Official Gazette no. 546/06.08.2009 ("GD 776/2009").

GD 776/2009 amends Government Decision no. 1680/2008 establishing a state aid scheme for ensuring sustainable economic development ("GD 1680/2008").

These amendments mainly refer to:

- Clarification of the activities to which the state aid scheme for ensuring sustainable economic development does not apply;
- The repeal of the list of activities not covered by the state aid scheme for ensuring sustainable economic development.
