#### Young Humanitarian Recipient

**IVAN KENNEDY**, 32, helps the hardcore poor including children, single mothers and the aged by educating, caring for them at his shelter home and feeding them at his Soup Kitchen Outreach. He also visits and provides rations to the Orang Asli.

#### Young Humanitarian Runner-up

**MURUGAN NAGU PANDITHAN**, 38, went to Aceh, Indonesia to help tsunami victims and to Balakot, Pakistan to help in the earthquake disaster as a member of the Malaysian Red Crescent Society which he joined as a teenager.

#### Young Humanitarian Finalists

**ABDUL RAQIB KARIM MOHD RAZHA**, 22, courageously helped a mugging victim at the risk of losing his own life, serving as a source of inspiration for other Malaysians. He was stabbed twice for his troubles and lost more than four pints of blood.

**AIZAN AZRINA ROSLI**, 32, spearheaded a programme called Projek Tekad, motivating and encouraging less privileged young Malaysians to excel in life. She also volunteers weekly at an orphanage, helping the children with their studies.

**HARUN MAT YUSOP**, 35, imparts his knowledge and skills as a chef with the hope of turning troubled teenagers into good citizens. He gives free cooking classes to the boys at Henry Gurney school every week.

#### Team Humanitarian Recipient

The **DEAF AGAINST CHILD SEXUAL ABUSE (DACSA)** team of six has relentlessly conducted awareness talks, workshops and education camps on one of the most neglected social issues - Personal Safety and Child Sexual Abuse (CSA) among the deaf. The team's Facilitator Handbook is now widely used as a sample in the teaching of CSA to other groups with disabilities.

#### Team Humanitarian Runner-up

**SATHYA SAI BABA CENTRAL COUNCIL OF MALAYSIA** is dedicated towards promoting human values across religious and social borders. It provides selfless service to the poor, sick and needy, promotes human values to youths and society at large as well as inter racial and inter religious harmony amongst the younger generation.

#### Team Humanitarian Finalists

**PERSATUAN PENJAGAAN ANAK-ANAK TERENCAT AKAL JOHOR** is a centre caring for mentally disabled and handicapped children. Established in 1990 with just seven inmates, the centre now houses 168 residents. The centre hopes that with proper education and attention, some of the children will attain independence as they mature.

**SUPERFLOW CENTRE** provides social, welfare and health services to the underprivileged. Professionally run by a group of volunteers and administrators, its community services include a dialysis centre, training centre for the mentally challenged, home for abandoned children, school for Down's Syndrome and autistic children and a training centre for the handicapped.

#### Lifetime Humanitarian Joint Recipients

**EMBUN MOHD ALI**, 87, has made caring for orphans her lifelong cause. She and her late husband funded the construction of Asrama Anak-Anak Yatim/Miskin Yayasan Hikmah in Gopeng with their own savings and pension in 1991. The Yayasan Hikmah was subsequently founded with Embun's 32 acres of land and other properties in its name. At an age when others would be content to stay at home, Embun is still an active adviser of the orphanage.

The late **MANIKUMAR KANAN**, 44, himself a disabled, dedicated his entire life to the welfare of others. His younger days as a volunteer at a home for the mentally and physically challenged, prompted him to set up a home for the disabled, Pusat Penjagaan Kanak-Kanak Cacat Taman Megah in 1997. He was the founder, director, manager, fundraiser and driver for the centre, which grew from four disabled kids to 138 currently. He died in an accident in April this year while on his way to sell tickets for a fund raising campaign for the Home.

#### Lifetime Humanitarian Finalists

**NGO YORK KONG**, 58, has spent the last three decades helping special children in Sabah. His own personal experience with bringing up a disabled daughter increased his empathy for others with any type of needs particularly those who are poor and/or disabled in any way. Beneficiaries of his dedication include Seri Mengasih Centre for those with intellectual disability and other developmental impairments. Ngo was also responsible for revamping the Special Olympics and introduced Climb Mount Kinabalu for special athletes.

**HENRY K. PILLAI**, 60, decided to devote himself to humanitarian works from the age of 26. Starting out with seeing to the needs of the poor in 1972, he went on to set up homes for orphans, abandoned and abused children and juvenile delinquents, unwed mothers and people living with HIV/Aids as well as centres for drug and alcohol rehabilitation, crisis counselling and creative arts resource for the underprivileged. All these humanitarian deeds are carried out under Grace Community Services which he founded.

**REV PETER JOHN YOUNG**, 80, is a passionate and visionary personality who has devoted his whole life to the betterment of marginalised citizens. He was the first Executive Director of Malaysian CARE and has moved on to start Dignity and Services, a registered advocacy group, promoting the interest and championing the cause of persons with learning disabilities (PLDs).

## Young Humanitarian Recipient

If you had six children of your own, would you adopt another four, especially if they carry the stigma of HIV/AIDS?

NORLINA ALAWI, 32, did just that when she established Pernim or the Nurul Iman Welfare Society for Children of People Living with HIV/AIDS.

The four children now live under difficult circumstances: they are offspring of parents who are either HIV positive or had died of AIDS.

#### Young Humanitarian Finalists

He trekked eight hours into a hillside padi farming community in Terian, Penampang to put up solar panels at a primary school to enable students to use a laptop for the first time. That is just one of many days in Adrian's Lasimbang's life.

ADRIAN LASIMBANG, 26, brings light and life to people in the deep corners of Sabah and Sarawak.

The Universiti Malaya graduate, a full-time volunteer with Partners of Community Organisations (Pacos), worked on seven projects to provide electricity supply to remote communities in Sabah and Sarawak.

The first thing officers in St. John noticed was his dynamic personality despite being raised by a single parent.

SIVA SARAVANA KUMAR GOPAL DASS, 26, was constantly struggling to make ends meet while pursuing his dream of being a doctor but it was his determination to help those in need that grabbed everyone's attention.

In 2003, he attended to 195 emergency cases ranging from accidents, heart attacks and even maternity cases.

The verification process, a phase after nominations are received and before judges evaluate entries, is entrusted to The Liaison Combination Sdn Bhd (TLC). TLC as a company, specialises in connecting business and society via corporate community involvement and HR services.

Nominees' deeds will be verified preliminarily by Brian Lariche and Mirella Soyer of The Liaison Combination Sdn Bhd (TLC) to ensure that only nominees who have met all criteria are eligible for judging by the Panel of Judges. Once verified, the list of eligible nominees will be passed to the Panel of Judges for selection.

YOUNG HUMANITARIAN is open to all Malaysian individuals aged 40 and below

TEAM HUMANITARIAN is open to organisations or groups of Malaysians comprising two people or more

LIFETIME HUMANITARIAN is open to all Malaysian individuals aged 40 and above

Demonstrated one or more of the following between 1st January and 31st December 2005:

A courageous deed involving personal self-sacrifice/going beyond the call of duty in the name of humanity and/or charity

A commitment to serving others demonstrated by an act or acts of selfless service

A generosity of spirit and a dedication resulting in the betterment of people in need (defined as needing shelter, food, clothing, education and meaningful employment) A meritorious direct "hands-on" participation in an act or operation of a charitable or humanitarian nature directly benefiting an individual or groups of individuals or community

Through outstanding involvement and dedication, have made a significant contribution of volunteer leadership or service which has improved or enriched the lives of others and the welfare of humanity and society as a whole

An act of kindness done without expectation of reward that has resulted in recognition by members of a community/family/institution

#### LIFETIME HUMANITARIAN AWARD

Demonstrated any one or more of the following acts/deeds consistently for a minimum period of 10 years including up to 31 December 2005:

Courageous deeds involving personal self-sacrifice/going beyond the call of duty in the name of humanity and/or charity

A commitment to serving others demonstrated by an act or acts of selfless service

A generosity of spirit and dedication resulting in the betterment of people in need (defined as needing shelter, food, clothing, education and meaningful employment)

A meritorious direct "hands-on" participation in an act or operation of a charitable or humanitarian nature directly benefiting an individual or groups of individuals or community

Through outstanding involvement and dedication, have made a significant contribution of volunteer leadership or service which has improved or enriched the lives of others and the welfare of humanity and society as a whole
