

Increase of maximum wage for social security contribution purposes/ Rritja e pagës maksimale për efekt të llogaritjes së kontributeve të sigurimeve shoqërore

5 June 2017

On 1 June 2017, the General Tax Directorate issued an announcement regarding the new minimum and maximum wage levels that became applicable beginning from May 2017.

The increase in the minimum wage which came into force on 3 May 2017, from ALL 22,000 to ALL 24,000, is accompanied by a corresponding increase in the maximum wage from ALL 97,030 to ALL 105,850.

The new minimum and maximum wage levels must be applied from and including the month of May 2017.

Rritja e pagës minimale e cila u miratua më 3 maj 2017, nga Lek 22,000 në Lek 24,000, shoqërohet nga një rritje korresponduese e pagës maksimale nga Lek 97,030 në Lek 105,850.

Nivelet e reja të pagës minimale dhe maksimale duhet të aplikohen nga dhe duke përfshire muajin maj 2017.
