**Re: Harlequin Boutique Hotel Limited – In Bankruptcy (“the Company”)**

To whom it may concern,

The purpose of this communication is to provide an update on the status of the Bankruptcy of the Company since my appointment as Trustee by the High Court of Barbados on January 12, 2018.

Pursuant to the Barbados Bankruptcy and Insolvency Act ("BIA") the first creditors meeting would have been held within 21 days of the appointment of the Trustee. However, after consultation with the Office of Supervisor of Insolvency in Barbados, it was agreed that this meeting would be deferred due to limited availability of financial information and creditor information. The Trustee sought and received approval of the High Court to extend the date of the first creditors meeting to March 28, 2018.

Towards the end of the month of March 2018 the Trustee was finally able to secure a significant volume of information on the creditors of the Company. However given the volume and complexity of the information received, the complexity of the Harlequin group corporate structure and potential for overlapping claims, the High Court of Barbados agreed to a further extension of the first creditors meeting to a date no later than June 28, 2018.

I am pleased to report that given the progress in the evaluation of creditors' claims, that first creditors meeting will take place during the week of commencing May 28, 2018, subject to approval by the Office of Supervisor of Insolvency. Notice of the specific date and time will be placed in the local newspaper, and a copy of this notice will be made available on the website (address shown below).
