The scholarship is awarded annually by the Firm to a student currently pursuing a Full Time undergraduate or graduate degree in Accounting; a student looking to start their tertiary education at an accredited institution in the Bahamas or abroad within the accounting discipline or a student interested in a career in public accounting. The scholarship amount will be disbursed at the beginning of each academic year.

Following a successful matriculation and attainment of a degree in Accounting, it is expected that the candidate must obtain one of the following certifications: Certified Public Accountant (CPA), Chartered Accountant (CA) or Association of Chartered Certified Accountants (ACCA).

The candidate must also be well rounded, as evidenced by community involvement, sporting or extracurricular activities and is of good character and integrity.

## What are scholarship recipients offered?

### Recipients will be awarded the following:



1. \$10,000 scholarship at the undergraduate level for local colleges and/or universities, or \$20,000 scholarship at the graduate level for local universities and up to \$20,000 scholarship for overseas universities. You can apply for the maximum per year depending on the degree program.
2. Valuable work experience in PwC's Internship/ Co-Op programs during the Summer, and Easter breaks will be expected, as agreed
3. Ongoing career coaching and support including one – on – one contact with your own individual PwC Professional coach
4. The opportunity to work part time with the firm during your senior year and/or full time after graduation and embark on a challenging and rewarding career

## Who should apply?



### Successful candidates must meet the following criteria:

- A Bahamian or Bahamian status holder student who is:
  - Currently enrolled at an accredited college or university in your second year or lower with a cumulative grade point average of GPA to 3.30 or higher having obtained at least 5 BGCSE passes (including English and Mathematics) with a minimum grade of B in at least 5 subjects.
  - Currently enrolled at an accredited college or university in your third year or higher with a cumulative grade point average of GPA to 3.30 or higher
  - Possession of a high school diploma
- A combined SAT score of not less than 1600 if taken prior to 5 March 2016, 1200 if taken after 5 March 2016, or a combined ACT score of 21 (if you studied abroad or sat locally)

### Local or Overseas Study?

**Local Study:** You could be funded to complete a Bachelor's or Master's Degree in the Accountancy discipline at a local accredited tertiary institution.

Instances where candidates have not attained 150 hours at the Bachelor's degree level, you may apply for funding with us to attend an accredited university to complete the difference of the hours required to qualify for writing the Certified Public Accountant Examination.

**Overseas Study:** Applicants for sponsorship at this level are generally expected to be currently enrolled at a suitable university overseas or to have completed an Associate's degree in preparation.

In certain exceptional cases, PwC will consider applications from students attending university for the first time.

Applications should be received by the first Friday in April each year. We will review all applications and interview potential candidates in May with decisions to be made by the end of May. If you are not successful, you will receive a notification by mail or email.
