## 账户注册



## 帐户注册 – 创建索赔门户账户

### 为什么？

- 欢迎FTX.com 或“FTX International”的所有客户均可向 FTX Digital Markets Ltd. (“FTX Digital”) 提出索赔。如果您是澳大利亚、欧洲、土耳其或日本的客户，您可能会被根据另一种流程进行处理。但是，如有疑问，我们欢迎您在巴哈马程序中提出索赔，联合官方清算人 (“JOL”) 将考虑您的索赔。
- 为了提交索赔，您首先需要在 FTX Digital Claim Portal 上创建一个账户。*注意：如果您之前已通过门户网站的初始版本 (此初始版本旨在注册客户联系方式) 提交了您的信息，您将收到一个链接，用于找回您的原始注册详细信息并设置新密码。请不要选择“Create Claim”按钮，因为这么做门户网站不会链接到您最初的注册信息。*
- 创建账户后，您将能够链接您的 FTX 账户、查看账户余额 (根据 JOL 记录) 并提交索赔 (如后续页面第 2 部分和第 3 部分所述)。

### 我如何创建账户？需要什么？

- 在 [FTX Digital Claim Portal](#) 的主页上，请选择“Create Claim”按钮以开始创建您的理赔账户。
- 您需要完成以下步骤来创建账户：
  1. 联系信息 (包括姓名、电话号码和电子邮件地址)
  2. 索赔人类型：
    - a. 个人客户 - FTX.com 或“FTX International”以个人名义提出索赔的客户
    - b. 机构客户 - FTX.com 或“FTX International”以公司名义提出索赔的客户
    - c. 非客户债权人 - 向 FTX Digital 提供商品或服务的贸易债权人，包括少数员工。*注意：非客户债权人将被手动处理，因此只需完成第 1 步 (帐户注册)，JOL 将联系后续步骤以提交您的索赔。*  
*请确保您在继续之前选择了正确的类型，因为在进入下一部分后您将无法更改您的索赔人类型。*
  3. 当前索赔人的详细信息 (包括姓名、出生日期和开户日期)
  4. 密码 - 该密码将是一个新密码，不需要与您的 FTX 账户关联的密码相同。密码长度必须至少为 8 个字符，并包含以下 **所有内容**
    - i. 至少一位数字
    - ii. 至少有一个大写字母
    - iii. 至少一个特殊字符 (!@#&()-:;?\*~\$^+=<>\_)
- 成功完成上述所有信息后，单击“Next”按钮，您将看到一个弹出窗口说明已发送带有验证码 (“one time PIN”) 的电子邮件，您需要在下一页中输入该密码。如果您没有收到电子邮件，请检查您的垃圾邮件文件夹，或者您可以单击重发验证码 (“Resend verification email”)。
- 如果您收到错误消息指出用户名已被使用，则说明您的电子邮件已经被创建了账户。如果您之前尝试过设置帐户，则需要取消现在的注册过程，请单击索赔门户主页上的登录 (“Login”)，再单击忘记密码 (“Forgot Password?”) 按钮并输入您帐户的电子邮件地址。然后，您将可以重置密码并通过门户登录页面上的登录 (“Login”) 按钮登录。  
*请确保您仅创建一个索赔门户账户，并将所有 FTX 账户链接到该账户 (请参阅下页第 2 部分，了解链接账户的说明)。*

## 登记债权人和客户账户详细信息 – FTX账户关联

为什么？

- 要提交索赔，您需要填写其他详细信息，以将自己注册为债权人，并将您的 FTX 账户链接到新的 FTX Digital Claim Portal 账户。
- 将您的 FTX 账户链接到 FTX Digital Claim Portal 账户后，您可以为所有 FTX 账户提交一份索赔，并可以（根据 JOL 记录）查看您的余额。
- 您可以接受 JOL 记录中的余额，也可以对您的余额提出异议，并进一步提供详细信息来证实您的索赔。

登记我的索赔需要什么？

- 设置帐户后，您可以随时使用用户名和密码登录。输入用户名和密码后，您将收到另一封包含验证码（“one time PIN”）的电子邮件，您需要在下一页中输入该密码。每次登录时都需要这样做，以确保您的帐户安全。
- 在门户的“Registration of creditor and customer account details”部分，您将需要输入以下详细信息：
  - 第 1 步：“当前索赔人信息”——填写所有必填字段（姓名、出生日期、电话号码、地址、居住国家或地区、职业、国籍、身份证号码）  
*注意：可接受/建议的身份证号码是护照、国民身份证和/或驾照执照号码，具体取决于司法管辖区。这是为了验证您的身份所必需的。*
  - 第 2 步：关联您的 FTX 账户 – 输入您所有 FTX 账户的电子邮件地址。这将允许您把所有 FTX 账户链接到一个 FTX Digital Claim Portal 账户。输入电子邮件地址后，验证码将发送到您链接的每个电子邮件地址，以验证您是否拥有这些帐户的权限。如果您收到一条错误消息“No FTX account found for email address”，则 JOL 记录会指示：
    - i. JOL 在此电子邮件地址下没有 FTX 账户的记录；或者
    - ii. 与该电子邮件地址关联的 FTX 账户余额为零或为负数。*如果您要对这一点提出异议，请通过 [abl\\_fdm\\_creditors@pwc.com](mailto:abl_fdm_creditors@pwc.com) 联系 JOL。*
- *注意：请确保您对所关联的帐户拥有合法权利和所有权，如果您不这样做，则可能会导致验证您的索赔的严重延迟或在无法验证您的身份时导致您的索赔被拒绝合法所有者。*
- 成功链接账户后，您将能够（根据 JOL 记录）查看您的余额以供审核，详细信息请参阅后续页面的第 3 部分。
- *注意：如第 1 部分中所述，非客户债权人将被手动处理，因此只需完成步骤 1 (Account registration)，JOL 将联系后续步骤以提交您的索赔。在此阶段，非客户债权人无需采取任何行动。*

    - 第 4 部分 - 获得/转让的索赔 - 如果您从另一方购买了索赔，请在此处相应地注明。
    - 第 5 部分 - 担保 - 如果您持有与您的索赔相关的任何担保(即抵押、押记或其他抵押品)。
    - 确认 - 输入您的姓名、身份、联系方式和签名。

为什么？

- JOL 采取的反洗钱 (“AML”) 和客户尽调 (“KYC”) 程序有助于确认债权人对其账户拥有合法权利，并有助于防止欺诈活动。
- 作为 KYC 程序的一部分，客户和非客户债权人需要提交身份信息和支持文件以供审核。这些程序有助于确认债权人身份和账户，并增强 FTX 数字索赔流程的安全性。

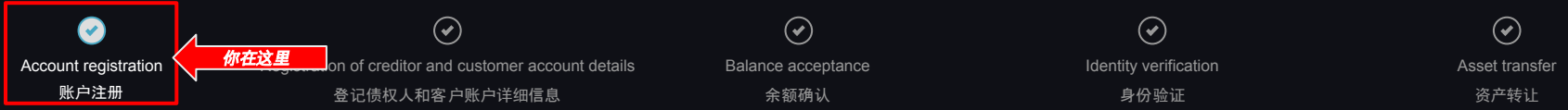

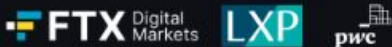

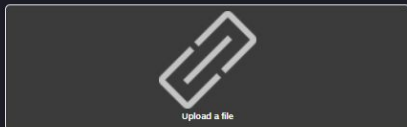
