- 1. A direction that the Settlement and Co-operation Agreement dated 6 January 2023 ("the Agreement") between (i) FTX DM, acting by its JPLs, and (ii) the companies in the FTX group of companies that filed chapter 11 cases in the United States Bankruptcy Court for the District of Delaware ("the US Bankruptcy Court") on 11 and 14 November 2022 (and whose names are listed in Annex A to this Summons), the effectiveness of which is subject to sanction of this Honourable Court and the approval of the US Bankruptcy Court, is hereby sanctioned by this Honourable Court on the grounds that:
 - a. The Agreement addresses questions which relate to and affect the assets and winding up of the Company; and/or

- b. that the entry into the Agreement is incidental to the exercise of the JPLs' powers to maintain the value of the Company's assets and to take possession of, collect and get in the property of the Company.
- 2. A direction that the Confidentiality Arrangements Agreement ("the NDA") dated 30th January 2023 is hereby sanctioned by this Honourable Court on the grounds that the NDA is in the interests of the Company.
- 3. An order that the costs of and occasioned by this Summons be paid out of the assets of the Company.
