Who is the ACCA DipIFR for?

This program is intended for professionals working in **accounting, audit and finance** who want to take a qualification exam in International Financial Reporting and broaden their knowledge of the theoretical and practical aspects of IFRS.



Eligibility

If you are working in practice, but not yet qualified, then you may still be eligible.

You will need to prove that you have one of the following:

- ❖ three years' relevant accounting experience (by submitting a letter from your employer); or
- ❖ a relevant degree plus two years' work experience; or
- ❖ an ACCA Certificate in International Financial Reporting (CertIFR) plus two years' work experience.



Exam Structure

DipIFR is assessed by a three-hour written exam held twice a year in December and June with a pass mark 50%.
