Change-ready teams

Why does the desired change (not) happen at the individual level? What could make our team more flexible? During successive transformations, the focus of change management advice is on the structured frameworks of organizational and team-level changes - in this training, we add the individual level to this: we provide ammunition for becoming more flexible in thinking, practicing letting go, and assessing and exercising control. We recommend it to proactive leaders who want to do this not only in the inevitable change processes, but also in temporary quiet times, to build a culture that makes their teams more ready for change.

On-the-job training

According to the results of our latest CEO survey, 82% of companies will invest in employee development in 2023, as a sign of preparing for the future. This does not necessarily mean new and new trainings, as the main part of learning takes place while working, and this is the largest part of the investment. In this training, we focus on supporting this. What should we pay attention to when accompanying on-the-job learning?

What aspects should we keep in mind when accompanying individual learning processes

and what system elements can we use to create a suitable atmosphere for this at the team level?

How do we ensure that the knowledge gained in off-the-job trainings is integrated?

We recommend it to everyone who is responsible for the on-the-job learning of others, or who is called upon to build a system for this in their team.

Retentive leader, retentive team

3/4 of people have already left their jobs because of their direct manager. In any forum we ask, the list of the strongest non-financial risks is headed by workforce retention. The motivation is legitimate, so that a manager's actions should not be a reason to lose talented colleagues, which is why creating a retention atmosphere is an increasingly valuable skill. In the training, we look at soft elements beyond the obvious factors of retention. How can a retention relationship be built and what makes a team (not) retainable? What makes a relationship more lively, a team more resilient? We recommend it to those who, whether as a leader, manager, or active group member, want to do more consciously for the retention power of their team.

June 18, 2025

Introvert-friendly leadership

Introversion is preferred by senior managers to a much lower degree than the percentage of introverts in the population. Numerous surveys prove that the world of work today is very "noisy", meaning that our processes are calibrated for extroversion. What would be a good thing for someone who works with introverts to pay attention to? Instead of solving trends at a macro level, the workshop aims to understand how things work and provide aspects for creating an environment where people can flourish regardless of their place on this scale. We recommend it to leaders and managers who want to work towards creating a culture that is inclusive from this perspective, or who are looking for ammunition for their personal leadership practice.


