### How the Global CEO Survey compared to the APEC CEO Survey

PwC conducted a survey from September to December 2016, involving 1,379 CEOs from 79 countries around the world, including Indonesia. Uncertain economic growth and over-regulation are the main concern of CEOs together with high unemployment, resource shortages and other challenges. Although 69% of the respondents said it is harder for business to sustain trust in a digital age, they believed that technology can create jobs for people who can design, monitor, maintain and fix technology. Meanwhile PwC also conducted a survey from April – July 2016 of 1,154 CEOs from 21 countries in the APEC region. These CEOs had the same concerns about uncertain economic growth, how to secure the strength of demand and the issue of over-regulation. 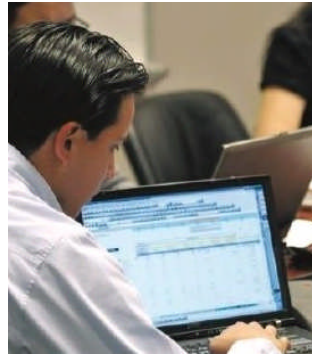
