VAT incentive for domestic flight tickets during the upcoming school holiday period

VAT incentive for domestic flight tickets during the upcoming school holiday period

On 4 June 2025, the Minister of Finance (“MoF”) issued PMK-36¹, providing a Value Added Tax (“VAT”) incentive in the form of partial VAT borne by the Government on domestic flight services for the upcoming school holiday.

This incentive applies only to economy class tickets for scheduled domestic flight services, for ticket purchases and travel between 5 June 2025 and 31 July 2025.

Under normal circumstances, these tickets are subject to VAT at an “effective” rate of 11%, in accordance with the provisions set forth in PMK-131². The VAT base includes all services provided by airline companies, (e.g. base fare, fuel surcharge and other costs paid by the passenger), excluding airport taxes.

The incentive under PMK-36 stipulates that the total 11% VAT will be:

- 5% borne by the service recipient (i.e. the passenger); and
- 6% borne by the Government.

Airline companies utilising this facility are required to:

- issue VAT invoices for the 5% VAT portion; and
- submit a detailed list of VAT borne by the Government electronically, no later than 30 September 2025.

The above VAT invoices and detailed list must be reported cumulatively in the relevant Monthly VAT Return.
