

**UPON** hearing the Application this day in presence of Counsel for the Applicant, Michael Simpson as liquidator of Shepherds Select Funds Plc (in liquidation) (hereinafter referred to "SSF") And having heard Counsel UPON CONSIDERATION had thereof **IT IS ORDERED** that:

- 1. Dr Owen Walcott; Mrs Birgit Hernelind; Mr Timo Salokoski; Mr Roland Patkai and Mr Stephen J.
