Reporting Workflow

- **Data Import** is via encrypted user upload (managed service) or automatic pull from your systems (in-house installation). **Data Validation** identifies errors and facilitates your **Data Correction**.
- **Data Conversion** generates properly formatted output files (e.g. XML) satisfying local regulatory requirements.
- **Data Approval** is granted by you, and then **Report Submission** will be performed by PwC or your entity, as desired.
- **Data Archiving and Audit Trail** maintains all the data and reports, as well as the workflow history, demonstrating and documenting your compliance.
- **Communication** letters can be generated per request, informing your customers of the data and reasoning of such reporting.
- **Workflow Management** allows you to easily track and monitor the status of the reporting process on a real time basis, to help you ensure compliance under FATCA, CRS, and UK CDOT in all relevant jurisdictions. Customized status reports can be generated for management reporting purposes.
