Available mechanisms to the creditors in Macedonia for securing their monetary claims - necessary legal documents and procedures, involved persons and institutions and certain specifics which should be taken into account: Contractual Pledge; Bill of exchange as executive deed; Agreement as executive deed; Debt Certificate; Banking Guarantees; Personal Guarantees; and Cash deposits.
