DATO' MOHAMMAD FAIZ AZMI AND DATUK ZAITON MOHD HASSAN ELECTED AS MIA PRESIDENT AND VICE PRESIDENT – AND OTHER KEY APPOINTMENTS

The Malaysian Institute of Accountants (MIA) is pleased to announce the election of Dato' Mohammad Faiz Azmi as the new MIA President and Datuk Zaiton Mohd Hassan as the MIA Vice-President for a new term. Both appointments took effect on 27 July 2015.

Dato' Faiz succeeded Datuk Johan Idris whose term ended on 15 July 2015.

Dato' Faiz is the Executive Chairman of PriceWaterhouse Coopers (PwC) Malaysia and has over 30 years of experience in the audit and business advisory services of financial institutions both in the UK and Malaysia. He has also been involved in the audits of clients in the banking, healthcare, power and construction sectors. He has led a number of projects relating to strategy, investigations and merger work both locally and internationally. He is also the Administrator for a national airline.

Dato' Faiz is the past Chairman of the Malaysian Accounting Standards Board (MASB) and a Council Member of The Malaysian Institute of Certified Public Accountants (MICPA). In addition, he is a member of The Association of Chartered Islamic Finance Professionals Malaysia and chairs the Asian-Oceania Standard-Setters Group on Islamic Finance. He is also a member of the International Accounting Standards Board, Committee on Islamic Product/Finance.

Dato' Faiz was educated in Malaysia and UK and read law at the University of Durham before being called to the English Bar. He is also a Fellow of the Institute of Chartered Accountants in England and Wales (ICAEW), a Liveryman of the city of London, and a member of the Worshipful Company of Chartered Accountants England and Wales.

Datuk Zaiton was first appointed as MIA Council member on 16 July 2013. She is currently the President of the ACCA Malaysia Advisory Committee. On the corporate front, Datuk Zaiton is currently the Managing Director of Capital Intelligence Advisors Sdn Bhd. She is the Chairman of the Private Pension Administrator Malaysia. She is also the Chairman of a public-listed company, Dolphin International Berhad, and Director of Sime Darby Berhad, BIMB Holdings Berhad and Bank Islam Malaysia Berhad.

She was formerly the President/Executive Director of Malaysian Rating Corporation Berhad (MARC). Prior to joining MARC, Datuk Zaiton served 12 years with Maybank in various senior positions including that of General Manager, Group Strategic Planning.

Also, four other members of the Institute have been appointed to the MIA Council, effective 16 July 2015.
