Submission guidelines

1. Make sure you qualify:
 - a. An undergraduate student currently studying in a university in Malaysia
 - b. A team of three (3) people
2. No participation fee is required.
3. All deliverables must be in English.
4. Submissions need to:
 - a. **Define the problem**
 - b. **Describe your objectives**
 - c. **Provide clear solutions to the issue**
5. Any additional elements like music, videos, animations, etc., must be inserted into your presentation pack. Your presentation should preferably be in PowerPoint, Prezi, or similar software.
6. The number of pages per submission should not be more than five (5).
7. Participants can only be in one (1) team and send in one (1) submission per team.
8. The email subject for submissions should be titled:
PwC Trust Builders – (your team's name)
9. In the email body, please include the following details:
 - a. Team members' names
 - b. Name of university
 - c. One (1) page profile of your team members in PDF
10. The deadline of the submission is **28 February 2017**. Submissions received after this deadline will not be accepted.
11. Be creative!

Creating the structure

Semi-final guidelines

1. Shortlisted teams will be invited to the PwC office in **1 Sentral** (near KL Sentral) to **present** their ideas (as submitted in Stage 1) to a panel of PwC judges.
2. All teams in the semi-final will be required to include a new section in their presentation to **demonstrate how to put their solutions into practice.**
3. Each team will be invited to present their solution to the issue. A maximum of five (5) slides is recommended.
4. Each team will be given five (5) minutes to do their presentation and five (5) minutes for a Q&A session.
5. Teams are required to submit their presentation materials by **12 noon, 22 March, 2017.**
6. All three (3) team members must be present during the presentation.
7. In the event that the number of participants in a team is reduced to less than three (3) members, the team shall be disqualified. However, PwC reserves the right, not to disqualify teams in which a team member had a legitimate reason to leave their team, as long as there are at least two (2) team members doing the presentation. Reasons considered legitimate include accidents or hospitalisation.
8. Special consideration will be given to teams from other states in Malaysia who are not able to present in our office. These shortlisted teams may be allowed to present live to our judges via Skype.
9. PwC holds the right to disqualify any team which does not meet these conditions.

**Submissions will be in the same format as the initial submission.

The Finished Product

The Finals

1. The Finals will be held at the PwC office at 1 Sentral.
2. The judging panel will be composed of PwC's senior management.
3. Minor changes from the semi-finals presentation slides are allowed, but need to be resubmitted by **12 noon, 29 March, 2017**.
4. Each team will be given five (5) minutes to do their final presentation and ten (10) minutes for a Q&A session.
5. All three (3) team members must be present during the presentation.
6. In the event that the number of participants in a team is reduced to less than three (3) members, the team shall be disqualified. However, PwC reserves the right, not to disqualify teams in which a team member had a legitimate reason to leave their team, as long as there are at least two (2) team members doing the presentation.
7. Special consideration will be given to teams from other states in Malaysia who are not able to present in our office. These shortlisted teams may be allowed to present live to our judges via Skype.
8. PwC holds the right to disqualify any team which does not meet these conditions.
