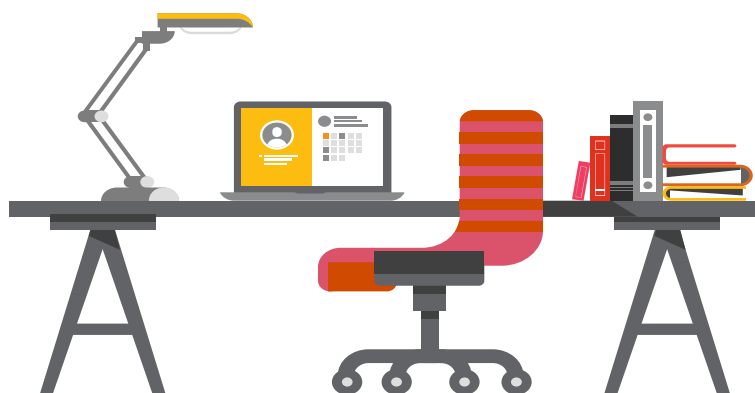

Are you the one? Minimum entry requirements

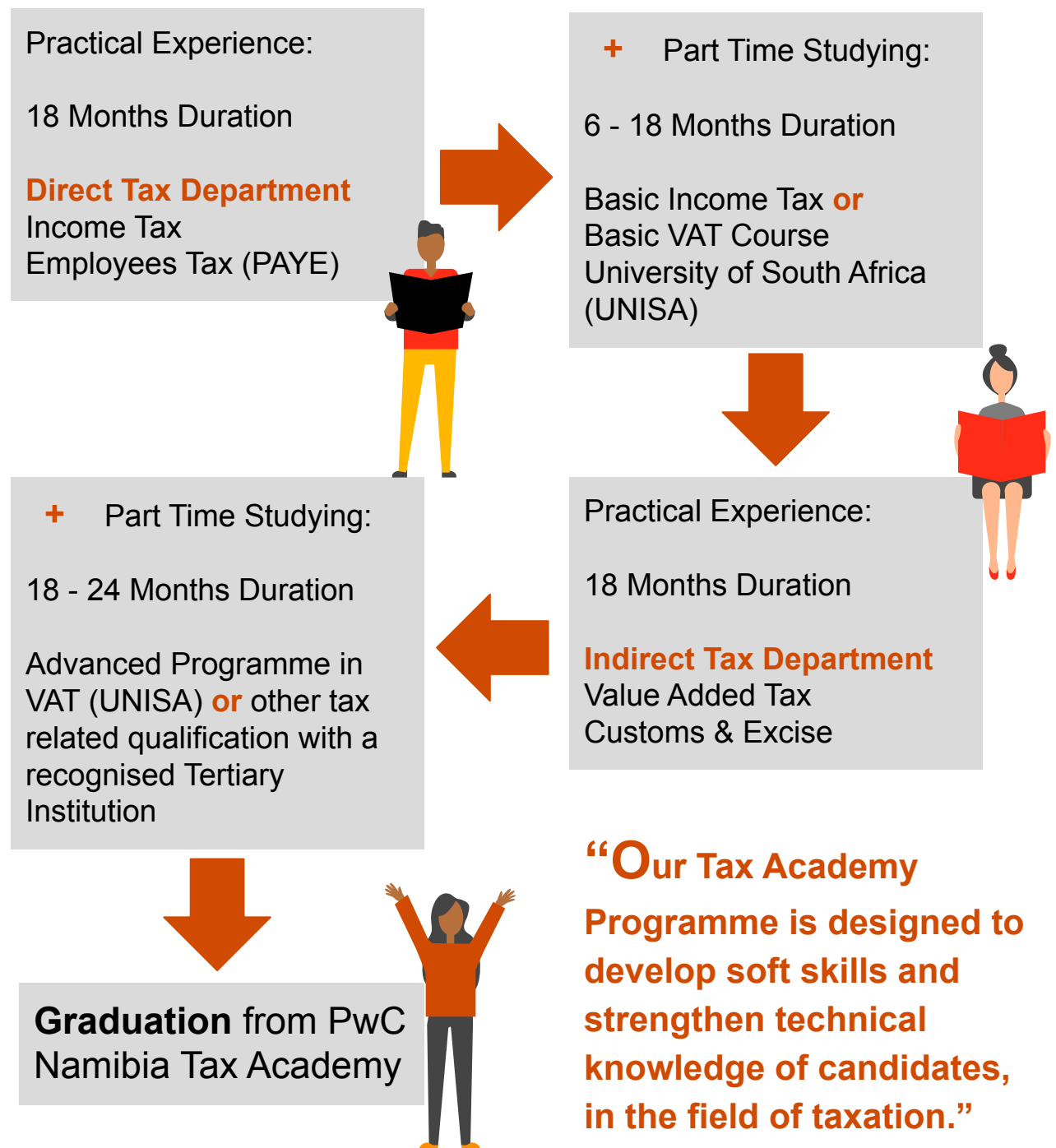
The minimum requirements for our Tax Academy programme are as follows:

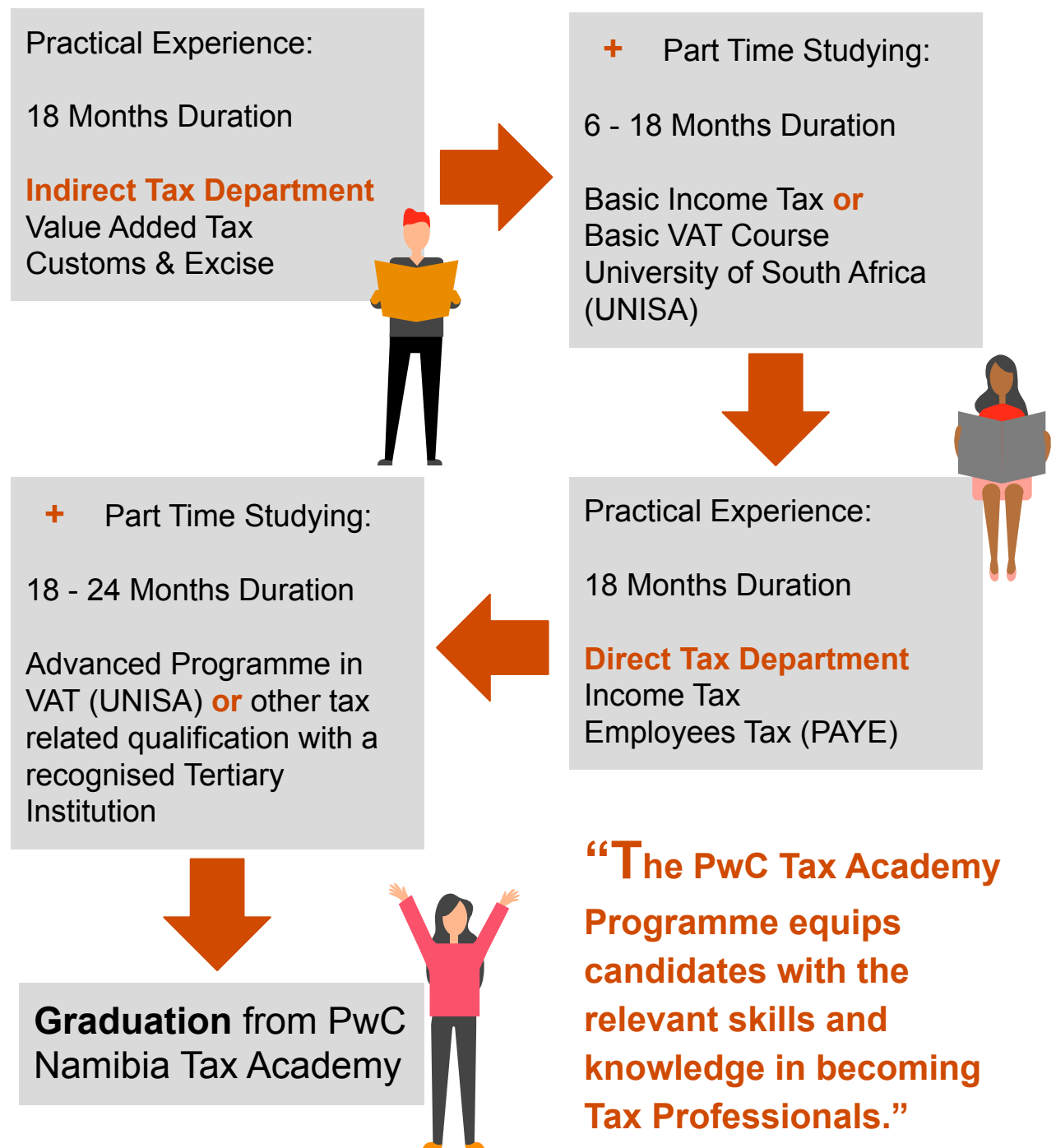
Tax Academy Programme Layout Route A

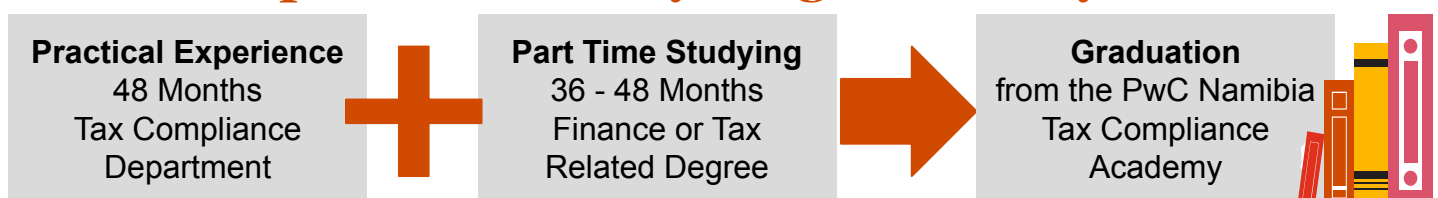


Are you the one? Minimum entry requirements

- Trainee will be required to study part time (any finance related streams e.g. Accounting or Tax Degree) at a recognised Tertiary Educational Institution
* subject to PwC Namibia's Study leave policy
- No prior work experience is required, but this may be considered an added advantage

- Must be able to meet deadlines, perform under pressure and manage multiple tasks

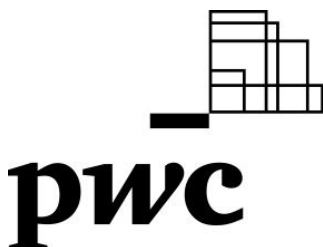
