Business growth:

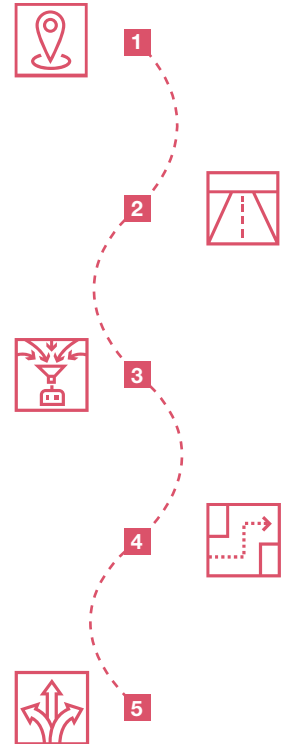

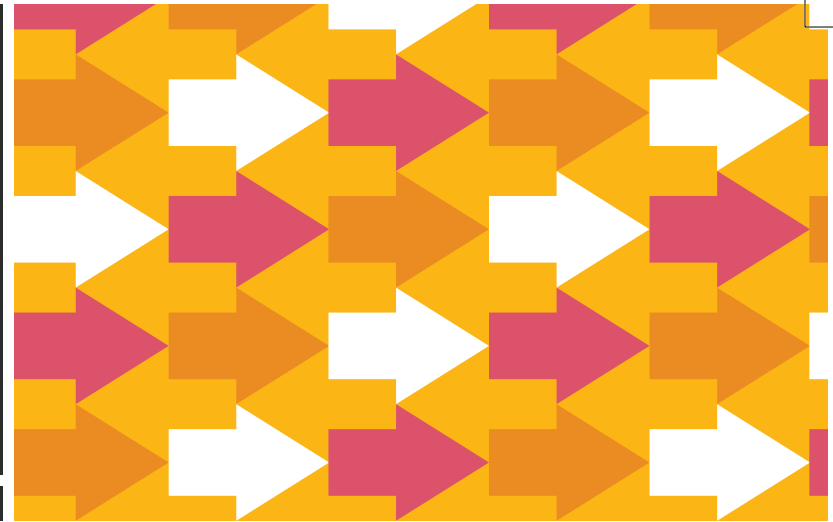
