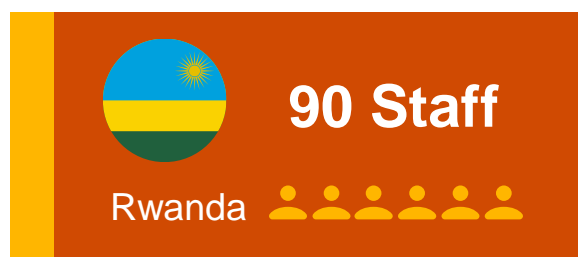


In Rwanda

01. Audit and assurance
