## 泰国 PDPA 的执行延至 2022 年 6 月 1 日

#### 概要:

由于疫情对各行各业产生了广泛而严重的影响,2021 年 5 月 8 日皇家法令宣布关于组织和企业不受个人数据保护法(No. 2)2021(以下简称"PDPA")约束,将延至2022 年 6 月 1 日。自 2020 年 5 月 27 日起生效至2022 年 5 月 31 日。此目的是将 PDPA 某些规定的免责期限再延长一年。

此延期不应被视为政府对于全面实施此法律有任何松懈。依法被视为"数据控制者"的企业仍须对个人数据采取安全和保护措施,并采取其他行动以遵守数字经济和社会部发布的关于 2020 年个人数据安全措施的标准。


