

- **Doing Business** annual survey of the World Bank and the International Finance Corporation, which starting from **2003 year** compares business regulations for domestic firms in different countries
- **Doing Business 2014** report is drawn on the inputs of more than 10,200 professionals, including PwC
- Economies are ranked from 1 to 189
- Ranking reflects the average result of 10 areas of the business activity covered by the study







#### **Comments:**

Ukraine made trading across borders easier by releasing customs declarations more quickly and reducing the number of physical inspections



However, still 75% of time to export and 70% of time to import relates to preparation of documents
