
Managing compliance risk for business visitors



This workshop will discuss:

- Trends of mobile travelers and their risk profile;
- Common misconceptions and challenges for compliance of mobile travelers; and
- Tax and immigration compliance risks.

Companies are sending more employees to Vietnam to meet their business needs and to seize opportunities. Human Resource and Finance teams may unknowingly assume that these visitors are not subject to tax in Vietnam as they are not on assignment. Additionally, they may incorrectly assume that employees spending less than 183 days in Vietnam are excluded from tax compliance requirements.

The reality is that every international employee travelling to Vietnam is exposed to tax and immigration compliance risks. The objective of this workshop is to explain the ongoing compliance obligations and how best to satisfy them.
